Introduction

Swift Scaffolding Ltd is a professional contributor to the construction industry.

Having a legal and compliant fleet is essential for a company in the construction sector.

They currently run six HGV's, 14 vans, 13 company cars and nine trailers, all of which are operated simultaneously from one site and handled by logistics manager, Mervyn Rolf.

Challenges

Swift Scaffolding Ltd have always been aware of the importance of having a safe, compliant fleet, and this is demonstrated by their commitment to FORS, having gained Gold accreditation.

It was vital for them to find a fleet management solution which could help with the monitoring and scheduling of all their key dates, such as MOT's, Services and road tax renewals as their previous processes for managing fleet created hours of cross referencing work.
